**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
IN SUPPORT OF ESTABLISHING A NO STOPPING OR STANDING REGULATION
ALONG ROUTE NJ 42 WITHIN THE CORPORATE LIMITS OF
THE TOWNSHIP OF MONROE**

WHEREAS, the Township of Monroe, County of Gloucester (hereinafter “Township”), values the safety and well-being of its residents and all those who travel within its borders; and

WHEREAS, Captain Mark Burton of the Monroe Township Police Department submitted a request on February 22, 2024, to the New Jersey Department of Transportation (“NJDOT”) to investigate the feasibility of establishing a “No Stopping or Standing” regulation along the entirety of Route NJ 42 within the Township; and

WHEREAS, following a thorough field investigation, the NJDOT has recommended the approval of such a regulation to enhance traffic flow and ensure the safety of motorists and pedestrians alike; and

WHEREAS, the NJDOT requires a resolution of support from the Township Council as a preliminary step in the Traffic Regulation Order (“TRO”) process to legally establish these regulations.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Township of Monroe, Gloucester County, New Jersey, as follows:

1. The Council hereby expresses its strong support for the establishment of a “No Stopping or Standing” regulation at all times, along Route NJ 42 within the corporate limits of the Township of Monroe, including both sides of the roadway, all ramps, connections thereto, and areas under the jurisdiction of the Commissioner of Transportation, except in areas where other approved parking restrictions are in place.
2. The Council directs that this resolution be submitted to the NJDOT, specifically to the attention of Ms. Jaime Oplinger, Director of the New Jersey Department of Transportation, as an expression of the Township's endorsement of the proposed traffic regulation.
3. The Council authorizes the affixing of the Township’s raised seal on this resolution as a mark of its authenticity and commitment to the safety and regulatory compliance within the Township.

BE IT FINALLY RESOLVED that this resolution shall take effect immediately.
