WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by letter dated August 31, 2023, required a Performance Guarantee (Landscape Buffer) amount and inspection escrow for the Site known as The Greens – Phase 3 (Block 14801, Lot 12); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee (Landscape Buffer) for the Project as follows:
