WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by revised letter dated March 23, 2023, required a Performance Guarantee amount and inspection escrow for the Site known as Grandview Mews (Block 801, Lots 7, 8, 10, 11, 14 & 15.01); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee for the Project as follows:
