**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE,
GLOUCESTER COUNTY, RELEASING RETAINAGE FOR THE FY' 2022 NJDOT
MUNICIPAL AID WHISPERING WOODS PHASE II**

WHEREAS, Remington and Vernick Engineers, in their capacity as project engineers, have overseen the completion of the Whispering Woods Phase II Project under contract number RVE #0811 T 099; and

WHEREAS, as per Remington and Vernick Engineers, South State General Contractors has satisfactorily completed the work stipulated under the aforementioned project, as per the Final Payment Certificate #3 dated April 10, 2024 (“Exhibit A”), and has thereby fulfilled their contractual obligations meriting the release of retainage; and

WHEREAS, the Final Payment Certificate #3 indicates a retainage amount of \$6,650.89 now due to South State General Contractors; and

WHEREAS, N.J.S.A. 2A:44-143 et seq. requires that upon satisfactory completion of a contract, all retainages held back from a contractor shall be released within a stipulated time period unless otherwise subject to claims or encumbrances against the project that justify withholding.

NOW, THEREFORE, BE IT RESOLVED, that the Township of Monroe Council authorizes the release of the retainage amount of \$6,650.89 to South State General Contractors for the work completed on the Whispering Woods Phase II Project.

BE IT FINALLY RESOLVED that this resolution shall take effect immediately.
