**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE  
AUTHORIZING SUBMISSION OF A GRANT APPLICATION AND TO EXECUTE A  
GRANT CONTRACT WITH GLOUCESTER COUNTY FOR FY 2024 COMMUNITY  
DEVELOPMENT BLOCK GRANT FUNDING FOR IMPROVEMENTS TO THE  
MUNICIPAL BUILDING WITHIN THE TOWNSHIP OF MONROE**

**WHEREAS**, improvements to the community that benefit all members of the community are desirable projects of the Township; and

**WHEREAS**, the Community Development Block Grant (CDBG) allows for the funding of projects which benefits all members of the community; and

**WHEREAS**, the CDBG allows for projects that improve public facilities, including the Municipal Building, located at 125 Virginia Avenue, where the ADA parking stalls, parking lot, and sidewalk require accessibility improvements; and

**WHEREAS**, the CDBG allows for projects that remove architectural barriers to improvement public facilities; and

**WHEREAS**, the above referenced project is eligible for the application for construction funding for the improvements, the softs costs related to the project shall be borne by the Township.

**NOW, THEREFORE BE IT RESOLVED**, by the Monroe Township Council that they intend to file an application with the Gloucester County Department of Economic Development through the Community Development Block Grant Program for the funding of accessibility improvements to the Municipal Building located at 125 Virginia Avenue.

**BE IT FURTHER RESOLVED** that the Mayor and Municipal Clerk are hereby authorized to sign the grant agreement on behalf of Monroe Township and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
