### AN ORDINANCE OF THE TOWNSHIP OF MONROE AUTHORIZING THE EXECUTION OF AN EASEMENT AGREEMENT AND OTHER RELATED DOCUMENTS WITH OCTAGON TOWERS, LLC TO COMPLETE THE CLOSING OF THE EASEMENT ACQUISITION

**WHEREAS**, the Township of Monroe (the "Township") is the owner of a communication tower located on the premises of 301 Blue Bell Street, Monroe Township, NJ (the "Premises"); and

**WHEREAS**, Octagon Towers, LLC (the "Grantee") seeks to acquire an easement under and around the communication tower located on the Premises and all related AT&T assets and improvements, including interest in tenant leases and all other related property owned by the Township; and

**WHEREAS**, the Township shall retain the right to continue to occupy its existing space on the communication tower with the Township's existing equipment or replacement equipment for the duration of the life of the communication tower; and

**WHEREAS**, Octagon Towers, LLC seeks to pay the Township \$475,000.00 for the acquisition of the easement on the Premises as described herein; and

**WHEREAS**, the Township of Monroe previously authorized the Mayor to enter into a Letter of Intent with Octagon Towers, LLC regarding the acquisition of an easement within the Township through Resolution No. 101-2023 adopted on March 27, 2023; and

**WHEREAS**, following a due diligence period, it is the intention of the Township and Octagon Towers, LLC to enter into a definitive agreement containing all of the terms and conditions regarding the acquisition of the easement under and around the communications tower on the Premises by Octagon Towers, LLC; and

**WHEREAS**, the Township Council of the Township of Monroe has determined that it is in the best interest of the Township to authorize the execution of the Communications Facility Easement Agreement and Assignment of Tower-Related Ground Lease (the "Easement Agreement") and any other related documents to complete the closing of the easement acquisition.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, as follows:

- 1. The Mayor and Township Clerk are hereby authorized and directed to execute the Easement Agreement, substantially in the form attached hereto, and any other documents necessary to complete the closing of the easement acquisition with Octagon Towers, LLC.
- 2. The Easement Agreement includes, but is not limited to, the following terms:
  - a. Grant of an easement in, on, under, and over the Premises as described in the Easement Agreement.

- b. Grant of access and utility easements as described in the Easement Agreement.
- c. Assignment of the Township's interest as landlord in the Tower-Related Ground Lease and all rental payments associated therewith.
- d. Easement term of ninety-nine (99) years with specific conditions for termination and surrender.
- e. Easement payments and other considerations as outlined in the Easement Agreement.
- f. Provisions regarding use, insurance, defaults and remedies, taxes, environmental matters, and other relevant conditions.
- 3. The Township Administrator of the Township of Monroe, the Mayor, the Township Solicitor, the Clerk's Office, as well as any additional Township staff and/or personnel are all authorized to take any action necessary to implement the terms of the Easement Agreement and to ensure the proper recording of the Easement Agreement and any additional closing documentation related to this transaction.

**BE IT FURTHER ORDAINED** that ordinances, resolutions, regulations or parts of ordinances, resolutions, and regulations inconsistent herewith are hereby repealed to the extent of such inconsistencies.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
