RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE AWARDING ENERGY AND GAS SUPPLY CONTRACTS FOR THE 7 MONTH TERM OF JUNE 1, 2024 THROUGH DECEMBER 31, 2024

WHEREAS, the Township of Monroe issued a Request for Proposals (“RFP”) dated May 6, 2024, for qualified third-party suppliers to provide electricity and natural gas under a fair and open process as stipulated by N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the RFP outlined the procurement of energy services aimed at securing a cost-effective and reliable energy supply for municipal facilities, street lighting, and other township utilities for the 7-month term of June 1, 2024 through December 31, 2024; and

WHEREAS, on May 6, 2024, bids for energy and gas supply were received at the following times from the respective suppliers:

WHEREAS, based on the lowest bids received on May 6, 2024, specific suppliers were contacted to provide refreshed pricing on May 8, 2024; and

WHEREAS, Constellation Energy Resources, LLC provided the lowest refreshed bid for both electricity and natural gas services.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of Monroe, New Jersey, that:

1. The bid to supply electricity and natural gas to the Township of Monroe is hereby awarded to Constellation Energy Resources, LLC, subject to their maintaining the lowest bid status in any subsequent pricing refresh and fulfillment of all proposal requirements.
2. The Township’s Business Administrator, Solicitor’s Office, Mayor, and Energy Consultants are authorized to execute a contract with Constellation Energy Resources, LLC for the provision of energy and gas services.
3. The execution of said contract is contingent upon the provision by Constellation Energy Resources, LLC of all necessary forms and documentation as required by State and Federal law, ensuring compliance with all regulatory obligations and standards.
4. This resolution shall take effect immediately upon passage.
