#### C.) MATTERS FOR DISCUSSION

Business Administrator, Jim DeHart spoke regarding the Cannabis Ordinance, noting the amendments that have been previously discussed, specifically the micro-dispensaries, which need to be addressed at the April Ordinance Committee Meeting. He also spoke in reference to the labor peace agreement, which does not provide much leeway with the way that it is written, and how the Township has had scenarios where the unions are not always able or interested in bidding on some of the smaller jobs. He and Cncl. Vice-Pres. Heverly have discussed adding additional language to the labor peace agreement, in order to ensure the flexibility with any of the new facilities that require renovations or construction. Cncl. Pres. Valcourt questioned how a micro-dispensary is categorized, to which Mr. DeHart explained, per state statute a micro-dispensary is 2,400 square feet or smaller. Solicitor Graise explained the current requirements that are contained within the current Ordinance. Mr. DeHart spoke in reference to the collecting of the local cannabis transfer tax and the lack of language pertaining to its enforcement, noting he would like to have this added to the amendments, as well.

Solicitor Graise spoke regarding Chapter 126 "Business Insurance Registration", noting there have been some concerns raised pertaining to non-profit businesses registering and paying the required \$50.00 registration fee. She believes it is prudent that the non-profits continue with the registration process; however, it will be up to Council to consider an exemption for the \$50.00 registration fee upon proof that the business is in fact non-profit, to which none of Council disagreed.

Main Street, and is a center for adults with special needs to help teach them life skills. On March 16th, he along with Cncl. Vice-Pres. Heverly, and Cncl. Fox attended the annual Easter Egg Hunt, which was a very well attended event. The Mayor thanked Director of Parks & Recreation, Brian Cope and the Parks & Recreation Commission, who are all volunteers for always putting on these great events for the community, noting they stuffed over 12,000 eggs with candy and treats for the children for this event. On March 19th, he attended the Senior Spring Luncheon. He thanked Director of Community Affairs, Donna Park, the Department of Community Affairs, and the volunteers on a job well done. On March 20th, he held a meeting with the Williamstown Fire Department to discuss and prepare some of the final steps needed prior to going out to bid on the new proposed firehouse, noting he is excited to finally begin this project, which has been stalled for a number of years. On March 21st, he attended a soft opening for IV On Main Aesthetics, a new business in town that will be offering rejuvenating IVs for individuals, along with facials and other spa services, noting they are currently open and accepting appointments. On March 23<sup>rd</sup>, the Mayor, Cncl. Vice-Pres. Heverly and Cncl. Fox attended the Ribbon Cutting Ceremony at All In Fitness, which is located in the business park on Route 322. The Mayor wished the owner many years of success. Also, on March 23<sup>rd</sup>, he attended the Ribbon Cutting Ceremony at Warrior Sun Yoga, located within All In Fitness, but it is two (2) separate businesses. The Mayor wished the owner many years of success. Mayor Wolfe noted that he attended the regularly scheduled Planning Board meetings this month, as well as many other Administration meetings and has officiated four (4) weddings. He wished Barbara Horcher, a supervisor in the Police Records Division, a happy retirement and well wishes in her next adventure. The Mayor mentioned that Administration has created a newsletter, which will be available in the Municipal Building, Public Works Building, Pfeiffer Community Center, Monroe Township Public Library and will be posted on the Township's website and social media pages. The newsletters will be provided quarterly, at very little cost to the taxpayers, and will be filled with a lot of great information regarding some of the past events, upcoming events, information about business and many other things that happen around town that people may not know about. Mayor Wolfe wished everyone a very Happy Easter.

**Business Administrator, Mr. DeHart** reported that the Township will be receiving a \$167,000 grant to be used for technology and security upgrades for the municipal complex. He has worked with both Fire Chiefs and Triad to apply for a grant that the Township will be receiving for new gear and SCBA for the fire departments in the amount of \$70,000, which both fire departments will be splitting. He noted that the grants take some pressure off of the taxpayers.

**Director of Code Enforcement, Mr. Sebastian** reported, for the month of February, the Construction Department has performed 252 building inspections, 79 fire inspections, 176 electrical inspections, 109 plumbing inspections, and 54 mechanical inspections, for a total of 670 inspections. The Housing Department has performed 174 inspections and the Zoning Department had 115 applications reviewed, for a grand total of 959 inspections for the month of January and year to date, 1,745 inspections.

Director of Community Affairs, Mrs. Park spoke regarding the Annual Easter Egg Hunt, noting that over the past two (2) years, the Department of Community Affairs has joined with the Parks & Recreation Department to help with the event, providing the special needs area for the event. She thanked the Williamstown Fire Department for the use of their ladder truck, which enabled her to take aerial pictures and videos of the event. On March 19<sup>th</sup>, the Senior Spring Luncheon was held at the Pfeiffer Community Center, celebrating St. Patrick's Day and Easter, with approximately 150 residents in attendance. She thanked all of the volunteers who beautifully decorated the center, set-up for the event and helped with serving. The Main Street Arts & Craft Festival will be held on April 13<sup>th</sup>, with a rain date of April 14<sup>th</sup>. This year's festival will take place on Main Street, from Church Street to Washington Avenue, from 10:00am to 3:00pm and will be the largest Main Street Festival to date, with over two hundred

(200) vendors and multiple food trucks already registered. Mrs. Park invited everyone to attend. On April 19<sup>th</sup>, the 2<sup>nd</sup> High School and Middle School Special Needs Spring Dance will be held at the Pfeiffer Community Center from 6:30pm to 8:30pm. The Autism Awareness Day Event sponsored by Community Affairs and Finn's Friends will be held on April 27<sup>th</sup> at the Pfeiffer Community Center from 11:00am to 2:00pm. The event will include sensory stations, bounce houses, character entertainment, music and dancing, mini golf, face painting, snacks and more. Mrs. Park advised that Bingo is held on the last Wednesday of the month from 12:00pm to 2:00pm and Community Affairs continues to give out produce, bread, and pastries weekly on various days of the week, as it becomes available. She reported that in March, the Department of Community Affairs were able to feed 1,803 families with all of the donations. She encouraged everyone to follow the Monroe Township Community Affairs Facebook page for more information on the various events and giveaways. Mrs. Park thanked Brandee Derieux and the entire department for planning and executing the events for the community.

Director of Parks & Recreation, Mr. Cope thanked the Parks & Recreation Commission for planning the Easter Egg Hunt and for everything that they do throughout the year for the residents of Monroe Township. He is pleased to announce that construction has begun at Owens Park to install four (4) new pickleball courts and one (1) tennis court, noting the old fencing was removed last week and the paving and resurfacing will begin mid-April. He noted, they are hopeful, weather permitting, that the new courts will be open for use by mid-June.

Chief Financial Officer, Ms. Boyer wished everyone a Happy Easter.

- Cncl. Fox commended the Parks & Recreation Commission and Community Affairs Department for a job well done with the Senior Luncheon and the Easter Egg Hunt. She attended the MMUA Meeting, Senior Commission Meeting, and Rent Leveling Board Meeting during the month of March. Cncl. Fox congratulated all of the new businesses and wished everyone a Happy Easter.
- Cncl. Garbowski advised that the Friends of the Library will be hosting their annual used Book Sale on April 27, 2024 from 10:00am to 3:00pm, with all of the proceeds from the sale benefiting the Monroe Township Public Library. He encouraged everyone to attend the sale. Cncl. Garbowski wished everyone a Happy Easter.
- Cncl. O'Reilly spoke in reference to the solar project at the landfill, noting the construction has begun and there is a target date for completion by the end of the summer.
- Cncl. Vice-Pres., Mr. Heverly thanked and congratulated the Parks & Recreation Commission, Department of Community Affairs and the Williamstown Fire Department on a fantastic Easter Egg Hunt. He wished everyone a very Happy and Blessed Easter.
- Cncl. Pres. Valcourt wished everyone a Happy Easter. She noted how proud she is of all of the sports teams in Monroe Township, commending the Mighty Braves Wrestling Team tonight on their dedication and success.
