WHEREAS, the Township Council of the Township of Monroe has determined that the renewal of the municipal cannabis license for Acreage CCF New Jersey dba The Botanist is in the best interest of the Township and its residents.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Monroe, Gloucester County, New Jersey, that the application for the renewal of the Class 5 Cannabis Retailer License submitted by Acreage CCF New Jersey dba The Botanist is hereby approved; and

BE IT FURTHER RESOLVED that this license shall be valid until August 31, 2025, subject to compliance with all applicable state and local laws and regulations; and

BE IT FURTHER RESOLVED that the Township Clerk is hereby authorized and directed to issue the renewed license upon receipt of the annual renewal fee of \$2,500 and to take any and all necessary actions to effectuate the terms of this Resolution.
