

**RESOLUTION R:261-2024**

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE,  
GLOUCESTER COUNTY, AUTHORIZING THE EXECUTION OF A SETTLEMENT  
AGREEMENT BETWEEN THE TOWNSHIP OF MONROE AND  
RODIER EBERSBERGER ARCHITECTS LLC**

**WHEREAS**, the Township of Monroe and Rodier Ebersberger Architects LLC (“Rodier”) were engaged in a dispute regarding certain invoices for architectural services rendered by Rodier in connection with the Williamstown Fire Station project; and

**WHEREAS**, both parties participated in mediation to resolve the dispute and have now reached an amicable settlement; and

**WHEREAS**, the Township of Monroe desires to avoid the costs and uncertainties of further litigation or mediation and believes that entering into a settlement agreement is in the best interest of the Township; and

**WHEREAS**, a Settlement Agreement and Release has been prepared and reviewed by the Township’s legal counsel; and

**WHEREAS**, the Township Council of Monroe has determined that it is in the Township’s best interest to approve the Settlement Agreement and Release with Rodier and authorize the Mayor to execute the agreement on behalf of the Township;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, that:

1. The Mayor of the Township of Monroe is hereby authorized to execute the Settlement Agreement between the Township of Monroe and Rodier Ebersberger Architects LLC, subject to the terms and conditions set forth therein.
2. The Township’s Solicitor and administration are authorized to take all actions necessary to effectuate the terms of the Settlement Agreement.
