**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE,
GLOUCESTER COUNTY, AUTHORIZING BID AWARD AND CONTRACT
EXECUTION CONTINGENT UPON SOLICITOR REVIEW AND APPROVAL FOR
THE 2023 & 2024 ROAD IMPROVEMENT PROGRAM**

WHEREAS, the Township of Monroe received bids for the 2023 & 2024 Road Improvement Program (Project No. 08-11-T-100) on September 17, 2024; and

WHEREAS, the Township Engineer has reviewed the bids received and has recommended that the contract be awarded to South State, Inc., P.O. Box 68, Bridgeton, New Jersey 08302, as the lowest responsible bidder for the total amount of \$1,900,251.40, representing the Base Bid and Alternate Bid Nos. 1, 2, and 3; and

WHEREAS, the Township is desirous of awarding the contract to South State, Inc., contingent upon the review and approval of the Township Solicitor and ensuring that all necessary funds are available; and

WHEREAS, in accordance with N.J.S.A. 40A:11-1 et seq., the award of this contract is subject to the Local Public Contracts Law;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, and State of New Jersey, as follows:

1. The contract for the 2023 & 2024 Road Improvement Program (Project No. 08-11-T-100) is hereby awarded to South State, Inc., in the total amount of \$1,900,251.40, contingent upon the review and approval of the Township Solicitor and the availability of funds.
2. The Mayor and Township Clerk are hereby authorized to execute the contract for the project, provided that such contract shall not be executed until it is reviewed and approved by the Township Solicitor.
3. The Township Engineer and other appropriate officials are hereby authorized to take any necessary actions to effectuate the purposes of this resolution.
