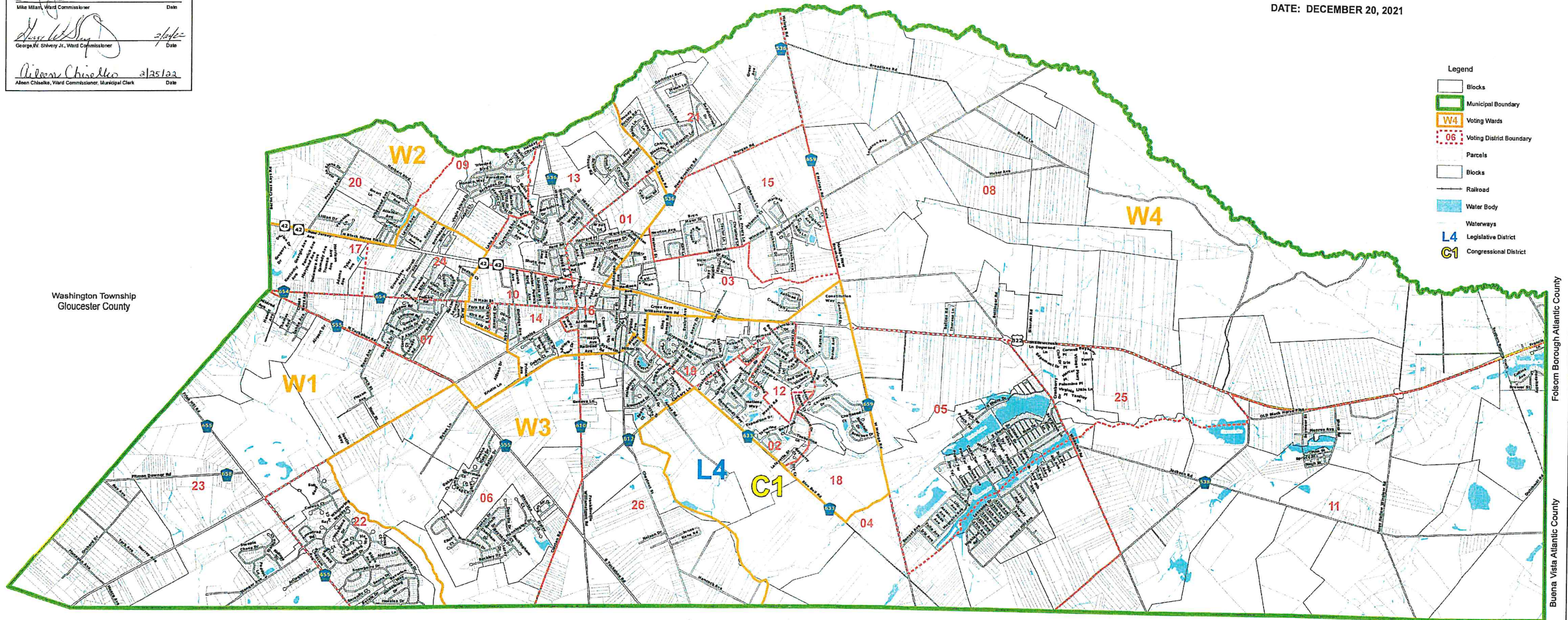
WARD & ELECTION DISTRICT MAP

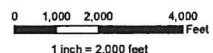
